# **2025 Marilyn Ott Memorial Scholarship**

**ONE \$500 SCHOLARSHIP AWARD AVAILABLE!** 

### DEADLINE: MARCH 1, 2025



SCCoLPA will be awarding one \$500 scholarship to a deserving high school senior, college student, or career change student. The scholarship will be awarded at SCCoLPA's monthly membership meeting in April 2025.

**CRITERIA:** Scholarships awarded are for applicants enrolled in college or school in the fall of 2025 and spring of 2026 and the eligibility requirements are as follows:

Category A – High School Senior (high school seniors who have successfully completed business, secretarial and/or law-related courses in high school and will be enrolled in the fall semester immediately following the school year in a college or business school offering a course of study in the legal field).

Category B – College Student (students who desire a career in the legal field, who have completed at least one year of college by June of the school year, and who will be enrolled in the fall semester immediately following the school year in a college or business school in a course of study in the legal field, until all such courses have been taken to satisfy the requirements for a degree or certificate in said legal related program).

Category C – Career Change Student (students who will be enrolled in the fall semester in a college or business school in a course of study in the legal field and shall be an individual who either (a) desires to re-enter the workforce but requires training or specialized education in order to qualify as a candidate for a position in the legal field; or (b) is currently working but desires to enter the legal field and wants to receive the training or specialized education needed to do so).

All scholarships under each category are applicable to California residents only.

Dear Educators and Counselors:

The purpose of this letter is to advise your students about the availability of scholarships for those students interested in a career in the legal field. For purposes of these scholarships, "legal field" is defined to include (a) legal assistant (including paralegal); (b) legal secretary (including receptionist); (c) court reporter; and (d) law office administrator. Both Santa Clara County Legal Professionals Association ("SCCoLPA") and Legal Professionals, Inc. ("LPI") provide scholarship programs to qualified applicants.

SCCoLPA, a local non-profit organization, is offering students the opportunity to apply for scholarships for two different Scholarship Programs:

- 1. The **Marilyn Ott Memorial Scholarship Program**, sponsored by SCCoLPA, offers students a \$500 scholarship award by (1) filling out an application, (2) submitting a biographical letter, (3) submitting an unofficial school transcript and if applicable (4) submitting a resume.
- 2. The **Eula Mae Jett Scholarship Program**, sponsored by LPI, offers students a \$2,000 first place and \$1,000 second place scholarship award by (1) filling out an application, (2) submitting a biographical letter, (3) submitting one letter of recommendation, (4) submitting an unofficial school transcript and if applicable (5) submitting a resume.

Legal Professionals, Inc. ("LPI") is a California non-profit corporation established in 1934. LPI is known for its educational programs, scholarship awards, and legal publications entitled "LPI Legal Professionals' Handbook" and "Law Office Procedures Manual." LPI has approximately 1,200 members in 29 local associations throughout California. SCCoLPA is the local chapter of

LPI and is dedicated to providing low-cost educational seminars and workshops to the legal community in Santa Clara County.

SCCoLPA will award a \$500 scholarship at its monthly membership meeting in April 2025. LPI scholarships will be awarded in May 2025 at the Annual Conference of LPI in San Diego, CA (the applicant need not be present to win). Scholarships awarded are for applicants enrolled in college or school in the fall of 2025 and spring of 2026. <u>The deadline for submission of a scholarship application is March 1, 2025.</u>

Scholarship awards under these two scholarship programs shall be given as follows:

#### <u>Plan A – High School Senior</u>

Applicants shall be restricted to seniors who will have successfully completed high school by the end of June 2025 and will be enrolled in the fall semester immediately following the school year in a college or business school offering a course of study in the legal field. All applicants must be legal residents of the State of California during the scholarship year.

#### <u>Plan B – College Student</u>

Applicants shall be restricted to students who will have completed at least one year of college by June of the school year, and who will be enrolled in the fall semester immediately following the school year in a college or business school in a course of study in the legal field, until all such courses have been taken to satisfy the requirements for a degree or certificate in said legal related program. All applicants must be legal residents of the State of California during the scholarship year.

#### <u>Plan C – Career Change Student</u>

Applicants shall be restricted to students who will be enrolled in the fall semester in a college or business school in a course of study in the legal field and shall be an individual who either (a) desires to re-enter the workforce after a prolonged absence but requires training or specialized education in order to qualify as a candidate for a position in the legal field; or (b) has been in the workforce for a number of years but desires to enter the legal field and wants to receive the training or specialized education needed to do so. All applicants must be legal residents during the scholarship year.

#### **INSTRUCTIONS ON APPLICATIONS AND SUPPORTING DOCUMENTS**

Applications and accompanying documents should be typewritten and on current forms. The Application Form (attached) specifies the rules and documents required for submission of an application for these scholarships.

Applicants must submit one unofficial transcript. LPI reserves the right at any time to request an official transcript from the applicant. "Official transcript" shall be defined as transcripts printed on original school letterhead. Copies of transcripts will be accepted if they contain either an embossed school seal or certification identifying the copy as a true copy of the original transcript.

The applications and supporting documents will be reviewed by a panel of judges. The judges shall take into consideration the following: (a) the applicant's desire to seek a career/position in the legal field; (b) the applicant's prospects for success in further education; (c) the financial need of the applicant; (d) the personal characteristics, aspirations and goals of the applicant, and (e) the applicant's extracurricular activities and what they have gained from them.

Please provide this cover letter, as well as the application form, to interested students. Santa Clara County Professionals Association (hereinafter "SCCoLPA") offers scholarships to persons desiring a career in the legal field. A career in the "legal field" shall be interpreted and defined as follows: (i) legal secretary; (ii) legal assistant (including paralegal); (iii) court reporter; and (iv) law office administrator. Scholarships are <u>not</u> intended for students planning to enter law school.

All applicants must be (i) legal residents for the State of California, (ii) attending school within the State of California during the scholarship year (September 1, 2025 through August 31, 2026), and (iii) enrolled in a program of no less than six months in duration. High school students who have not yet finalized their college plans acknowledge that the decision to attend school outside of the State of California, even if such decision is made after a scholarship has been awarded, will result in the forfeiture of the scholarship award.

The application and accompanying documents (see checklist) should be typewritten and on current forms.

Letter should state the reasons why applicant should receive a scholarship, academic achievement of the applicant, applicant's motivation to pursue a career in the legal field, applicant's future goals, and applicant's financial need. The letter should be typewritten on 8.5" x 11" paper and addressed "To Whom it May Concern."

#### UNOFFICIAL SCHOOL TRANSCRIPT

SCCoLPA reserves the right at any time to request an official transcript from the applicant. "Official transcript" shall be defined as transcripts printed on original school letterhead. A copy of the transcript may be accepted if it contains either an embossed school seal or certification identifying the copy as a true copy of the original transcript.

**RESUME** (Category C only)

The resume should list applicant's legal and/or secretarial experience, if any. Resume must include dates of employment, employer name and address, position, and reason for leaving.
